6. That school is not paying any charges towards using name, motto, logo, or any other non-academic activities to any other institution organization or body organization.

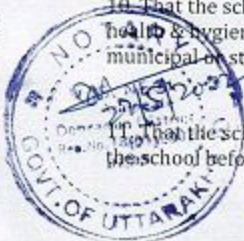
7. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
